




ANNUAL REPORT 2016- 2017

Founded in 2007, Atma has worked with 50+ educational NGOs and reached out to over 71,000 beneficiaries from the communities in the Mumbai and Thane region (as of April, 2017).

He studied Economics at Elphinstone College, Mumbai. Later, he earned his BA in Film at Stanford University, an MS in TV-Radio at Syracuse University, and a Ph.D. in Communication Research from Stanford University. After returning to Mumbai from the US in the mid-90s, he focused his career on pro-social TV serials. Upon witnessing the true need of Mumbai's NGOs and a brief encounter with Atma founders Hayley Bolding and Adrienne van Dok, Dr. Sood agreed to support Atma's vision.

Accelerator Programme

Atma was founded in 2007 to support and strengthen education organisations in the Mumbai region and Pune. Atma believes that these organisations can lead the way in reforming education but, faced with a severe lack of financial and human resources, they are unable to realise their true potential. To this end, Atma developed the Accelerator Programme which consists of a three-year partnership designed to resolve the organisational challenges the partner organisations are facing, thus allowing them to become better, stronger and more sustainable.


Upon joining the Accelerator Programme, the leader(s) of the education organisation work in close collaboration with a **Partnership Manager** who will provide ongoing guidance and support throughout the partnership. Together, they will:

- Identify the crucial challenges the organisation is facing and develop a plan to resolve them.
- Design and implement projects to put in place strong systems and processes that will resolve one-by-one the difficulties the organisation is encountering.
- Reinforce the strategy planning of the organisation by clarifying the vision and long-term plans of their leaders.

In addition to the partnership manager, Atma recruits **expert volunteers** who have the skills and experience to support the partnership managers during the implementation of projects.

Atma also aims to develop the organisation's **network** of funders, partners and consultants by providing resource linkages and by marketing the organisations.

Overall, the Accelerator Programme provides a holistic approach to capacity building for education organisation to become sustainable and impactful so that as a consequence, they become better equipped to resolve the education needs of India.



The Accelerator Programme in numbers:

1200 hours of support provided per year by the Partnership Manager and Atma team members to the organisation's leaders. At least **3 expert volunteers** per year to implement the projects designed during the partnership. Advice and expertise provided across **10 Organisational Development Areas** to answer the variety of challenges the organisations are facing.

Set up in November 2016, Gati is a consortium of Atma that aims to develop and disseminate best practice and address mutual challenges in the education for persons with disabilities. As of March 2017, it is a cohort of 25 members conducting the platform through bi-monthly meetings and exposure visits, that aim to address challenges focused on the needs of specifically, students with intellectual disabilities and mental or developmental disorders.

Globally, 98% of children with disabilities do not have access to the education they need.

Relative to mainstream education, the special education sector receives little attention, even while students with special needs face often greater barriers to access and learning.

Over the last three years, Atma's Accelerator Programme has worked with 14 organisations in the special education sector, who have collectively reached over 3500 children with special needs (CWSN). The initial four such organisations that we worked with showed excellent ability to grow and sustain their reach; these successful partnerships drove Atma to expand our work to a further ten organisations in SE.

Some common features we identified across this new cohort included:

- 1. Controlled student to teacher ratio
- 2. Focus on completion of Std.X through NIOS
- 3. Lacking student assessments, verified against externally- validated benchmarks for students' progress
- 4. Low scalability of models and low focus on systems development

Zooming out to the sector of players who take up education for PWD, we found evidence to support:

- 1. Common to the education sector, government regulation focuses more on resource allocation and physical infrastructure solutions, rather than provision of quality education
- 2. Factors exacerbating this situation within the indian scenario include a relatively young industry of practice and a focus on individual interventions rather than scalable models
- 3. An overall lack of information about this sector in the general population and an overall lack of regulation of services offered

Overview of activities

Bi-monthly meetings

These are meant to be a prime point of interface between stakeholders involved with Gati. Organised and facilitated by Atma, each Bimonthly builds on the preceding agenda on 1-2 focus areas (of 3, mentioned earlier). The meeting focuses on showcasing best practice from players in the disability space, which is followed by a discussion on its suitability to the space and to the cohort's organisations.

Outputs:

- 1. 3 bi-monthly meetings held over 5 months
- 2. Identification of focus areas and planning have been completed for 2 working groups
- 3. 3 newsletters have been published

Exposure visits

The function of exposure visits is to allow educators to see firsthand how other educators work. Visits are organised both to sites of Consortium members and to high-income schools that operate "without" resource constraints. This will increase exposure to both local best practices and some international best practices.

Outputs:

- 1. 2 site visits in the first 5 months (through the end of fiscal year), of which the first was a peer visit to Gati member VASS's centre and the other was an exposure visit to advanced stage organisation SPI Sadhana
- 2. 1 learning blog published so far, on segregated versus inclusive curriculum frameworks; 1 more blog in pipeline on SPJ Sadhana visit

Working groups

Working groups will be formed around key topics identified by the Consortium group. Each working group is expected to research solutions, identify locally-appropriate solutions, articulate research and recommendations in writing and/or move towards actions. Atma will aid in the writing process.

Outputs:

1. 4 partnerships between Consortium members were seeded by the Gati platform

Gati expected outcomes

- 1. Increase in awareness of the challenges in the special education space.
- 2. Formation of partnerships between members.
- 3. Creation of meaningful, locally-researched white papers.
- 4. Attribution to Consortium of follow-up actions and practitioner changes.
- 5. Increased partnerships with national and international disability and special education bodies.
- 6. Increased accessibility to resource linkages within and outside the cohort.

Volunteer Programme

Atma provides volunteering opportunities to talented candidates across the world to apply their skills in a challenging work environment in Mumbai. Volunteers are an integral part of Atma's workforce contributing to over 70% of our work with education NGOs and social enterprises.

By matching skill sets and interests with the needs of organisations in the Atma portfolio we identify exciting projects for volunteers. Through these projects, volunteers under Atma's guidance bring in expertise and experience to put in place much needed systems and processes in our partner organisations.


Atma Consultants

Between 2016 to 2017, around 453 candidates applied for the Atma Volunteer Programme. Only 81 highly skilled volunteers were selected.








Fundraising: Total raised in 2016- 2017
